VIII.C PROPOSED AMENDMENT TO THE BRADLEY UNIVERSITY SENATE CONSTITUTION Chapter I Section E Article II 1. Membership - Paragraph 1

Current Language:

ARTICLE II – UNIVERSITY SENATE

1. Membership

1. The President and Vice Presidents of the University, Deans of Colleges and the Graduate School, the Associate Provost for Student Affairs, the Associate Provost for Information Technologies and Resources, the Associate Provost for Enrollment Management, and the Registrar shall be ex officio members of the <u>University Senate</u>.

Proposed Change (changes in bold)

ARTICLE II – UNIVERSITY SENATE

1. Membership

1. The President and Vice Presidents of the University, Deans of Colleges and the Graduate School, the Associate Provost for Student Affairs, the Associate Provost for Information Technologies and Resources, the Associate Provost for Enrollment Management, **and** the Registrar, **and the Immediate Past President of the University Senate** shall be ex officio members of the <u>University Senate</u>.
