B. Proposed Academic Regulations change to Graduation Honors Policy-

Cum Laude, Magna Cum Laude, Summa Cum Laude

By commencement honors, Bradley University recognizes a student's superior scholastic achievement. Evidence of achievement is shown by the student's grade point average (GPA). To be awarded special honors at Commencement, a student must have earned and/or be registered for a minimum of 60 semester hours in residence at Bradley University. A student will be awarded Commencement Honors according to the following standard:

3.40-3.59 Cum Laude3.60-3.79 Magna Cum Laude3.80-4.00 Summa Cum Laude

For recognition at Honors Day and at Commencement, the computation of the Honors designation earned by GPA shall be made on the basis of cumulative GPA and hours completed at the end of the semester immediately preceding graduation (normally after seven semesters of work). The computation of the GPA for Honors designation on the student's permanent record and diploma shall be made on the basis of all work completed at Bradley University at the time of graduation the degree is awarded.

Students who have successfully completed the requirements of the University Honors Program will be recognized for this achievement by a separate certificate.

C. Proposed Faculty Handbook change to Sabbatical Leave Policy

Current/Amended Language: Chapter 2, Section B, Subsection 2e, no. 1, p. 41.

Tenured faculty members are eligible for sabbatical leave after six years of fulltime service on the faculty. Faculty and other stakeholders can refer to the following website <u>www.bradley.edu/path/</u> to determine eligibility to apply for sabbatical leave in the upcoming academic year.

In the case of a faculty member whose tenure package is under review, the granting of sabbatical leave is contingent upon earning tenure. Sabbatical leave may be granted to a full-time faculty member after six years of full-time service on the faculty. Unpaid leaves of absence normally will not count toward the six years. Sabbatical leaves carry half salary for the year or full salary for one semester. Faculty members granted sabbatical leave must agree to return to the Bradley faculty for at least one year after the expiration of the leave or repay to the University the amount of salary received while on leave. Application for sabbatical leave must be presented to the department chairperson, who, together with the dean, will forward the application to the Provost and Vice President for Academic Affairs. Recommendations and all comments relating to sabbatical

leave applications should accompany the applications through the various committees to the Provost and Vice President for Academic Affairs.

Amendment (PASSED December 10, 2014): strike the paragraph on p. 28 concerning the IAI from the motion on the floor and second, to refer that paragraph to the Curriculum and Regulations Committee for further study and subsequent recommendation to the Senate."

Motion to Amend: Add a sentence that is highlighted below to the last paragraph of page 5 of the Bradley Core Curriculum Model. (or page 15 of BCC attached to agenda) of the APPENDIX 1 of the Agenda and minutes of Nov. 20, 2014 *Motion by Ahmad Fakheri / 2nd Jean Marie Grant – Motion Approved*

"Core Practices

While most realize the Core Curriculum and the Major are integral parts of the Bradley Academic Experience, they may perceive the numerous majors and minors to be separate and distinct from one another. Far from it. The Core Practices, the third element of The Bradley Academic Experience, are the effective educational practices that permeate the academic programs on campus. These include high-impact practices such as writing intensive courses, internships, capstones, service learning, first-year seminars, collaborative scholarship, and study abroad. *The Core Practices will be integrated into the Core Curriculum areas of inquiry courses and those in student's program of study, and do not represent additional course work requirements beyond those*. The Bradley Core Curriculum will include two Core Practices: writing intensive courses (WI) which extend writing instruction and practice beyond the dedicated composition courses, and integrative learning courses or experiences (IL), which facilitate students' ability to make connections among classroom, co-curricular, and off-campus experiences. Two Writing Intensive courses will be required; a minimum of two Integrated Learning experiences will be recommended, but not required."

Motion to Amend: Strike the first part of the sentence on p. 28 of the BCC concerning the Communication writing requirement ("Courses approved for an Area of Inquiry may not also carry the tag of a cognate Core Practice, e.g., courses satisfying the Communication writing requirement cannot also carry the writing intensive tag,") and to capitalize the letter "C" in the following word "courses" in the motion on the floor and then to refer that sentence to the Curriculum and Regulations Committee for further study and subsequent recommendation to the Senate.. The paragraph would then read:

"With some exceptions, a course approved to satisfy an Area of Inquiry may also carry Core Practices tags. Courses satisfying the Multidisciplinary Integration requirement cannot also carry the Integrative Learning tag."

The following courses may be used to fulfill the requirement for the B.S. degree—all courses in astronomy (AST), biology (BIO), chemistry (CHM), computer science and information systems (CS and CIS), geological sciences (GES), physics (PHY), science (SCI), mathematics (MTH, except MTH 109); any course cross-listed with a course offered under any of the prefixes listed above; any course approved for QR or NS credit; and, in addition, all other courses approved for B.S. credit by the University Senate."

C. Resolution for an Annual Report on Improving the Funding for the Academic Mission:

Whereas Bradley faculty and staff are whole-heartedly committed to the long-term prosperity of our institution;

And whereas recent discussion of Bradley's budgetary priorities have highlighted excessive spending in various parts of the university but has often overlooked the budget for our academic mission;

And whereas the October 2014 report by the Senate Resource Committee indicated that instructional/research spending as a percentage of net tuition is at a 10-year low; And whereas our accreditation body, the Higher Learning Commission, provided valuable feedback on Bradley's execution of their academic mission in 2010, we move that the Provost and Vice President for Academic Affairs and the Vice President for Business Affairs, provide the University Senate with an annual report with question and answer period each April detailing what was done last year and the plans for the coming year to address the following issues and any others that are relevant to promoting and supporting academics until the issue of a new accreditation report;

The afforementioned issues can be organized under two key points raised by the HLC: <u>Funding the Academic Mission of Bradley</u>

1) "Academic programs have gone five years without an increase in operating budgets. This raises the issue of whether solid academic programs are beginning to be stretched in terms of resources at the same time that the institution is seeking national distinction" HLC pg. 17, 2010*

- Academic department budgets across the colleges have been flat for more than 10 years, forcing many to rely on gift accounts for regular operating expenses;
- The need to improve instructional and research technology [cf HLC, pg. 5 :"The gap between (students') expectations and what is available at Bradley should not be large or require an explanation or apology").
- Insufficient funding for general education innovations to make Bradley more attractive to new students (e.g., despite faculty support, insufficient funding for freshman seminars)

Investment in Faculty

2) "CUPA comparison data reveal that, with few exceptions, faculty salaries are below the averages for their respective comparison groups. This situation should be carefully monitored and hopefully addressed in the near future" HLC pg 19, 2010

- Inadequate funding and lack of directed fundraising for Bradley's Special Emphasis (cf, HLC, pg. 26 "A full commitment to student-faculty collaboration on the part of the University should include a solution to the current situation in which...many faculty mentor significant numbers of students during the summer months without compensation");
- Longstanding difficulty in recruiting and retaining high-quality new faculty.
- Collections and academic support at the library have been hampered by cuts and insufficient funding;
- A failure to find a permanent director of the Center for Teaching Excellence and inadequate compensation and budget for interim directors.
