#### VIII. New Business

**A. Core Curriculum General Policies** - The Sub Committee on Core Curriculum Committee proposed a number of additional statements to the Bradley Core Curriculum General Policies. The Committee on Curriculum and Regulations approved the additions on February 2, 2016. The additions now come before University Senate for consideration.

The proposed additions, in red font and underlined, appear within the current BCC General Policies (p. 28) which was approved by Senate in February 2015.

#### i. Bradley Core Curriculum General Policies

The General Policies of the Bradley Core Curriculum adapt existing policies and codify existing practices. (Current general education policies may be found in section III above)

• To be approved for an Area of Inquiry, a Bradley University course shall typically be three credit hours. A course may be approved for more than one Area of Inquiry, but it can be used by the student to satisfy only one Area of Inquiry.

• A course approved to satisfy an Area of Inquiry and/or carry Core Practices tags may also be used to satisfy college and/or major/minor requirements.

• With some exceptions, a course approved to satisfy an Area of Inquiry may also carry Core Practices tags. Courses approved for an Area of Inquiry may not also carry the tag of a cognate Core Practice, e.g., courses satisfying the Communication writing requirement cannot also carry the writing intensive tag, courses satisfying the Multidisciplinary Integration requirement cannot also carry the Integrative Learning tag.

• Approved Advanced Placement (AP), International Baccalaureate (IB) and College-Level Examination Program (CLEP) examinations may be used to meet Area of Inquiry requirements.

• <u>Transfer students who have earned at least two semester hours of approved</u> coursework in an Area of Inquiry are considered to have satisfied completion of one course in the Area of Inquiry. This policy is limited to students who transfer from an institution using the quartile system.

• <u>Transfer students may use courses taken at their previous institution to meet</u> Bradley Core Curriculum requirements. Case-by-case transfer course articulations will be determined by the Chair of the Core Curriculum Committee.

• <u>Transfer students may use courses taken at their previous institution from the Fine</u> Arts (FA) and Multidisciplinary Integration (MI) Areas of Inquiry to meet one or both of their two additional Bradley Core Curriculum elective courses. Students will be limited to no more than two courses in each Area of Inquiry.

• Bradley University participates in the Illinois Articulation Initiative (IAI). Transfer students from participating IAI institutions who have completed the IAI model general education curriculum prior to matriculating at Bradley will be granted credit for all Bradley Core Curriculum requirements.

• <u>Transfer students who complete all but one Illinois Articulation Initiative (IAI)</u> <u>General Education Core Curriculum (GECC) requirement will be allowed to complete</u> <u>their GECC and Bradley Core Curriculum requirements with one additional course taken</u> <u>at Bradley or at their previous institution following matriculation to Bradley.</u>

• Bradley University courses that have been approved by IAI as GECC classes will be so designated in the undergraduate catalog.

• <u>Transfer students enrolled in a second baccalaureate program will be automatically</u> granted credit for all Area of Inquiry requirements upon verification that their first baccalaureate was completed at an accredited institution of higher education that requires a minimum of 30 hours of non-theological general education.

• <u>Students who matriculate into Bradley prior to Fall 2016 will be offered the choice</u> of completing the General Education requirements as listed in the Undergraduate Catalog of their year of entry or the Bradley Core Curriculum as listed in the 2016-2017 Undergraduate Catalog, pending approval by their program administration. Students must submit their request to meet the Bradley Core Curriculum requirements by May 2, 2017. This supersedes the following policy in the Undergraduate Catalog under All-University Degree Requirements:

"Students who maintain continuous enrollment and who complete work toward the baccalaureate degree within five years from the date of entry may graduate under either the catalog in effect at the time of entrance or under the catalog in effect at the time of graduation." [Note, this policy will automatically expire June 1, 2017.]

• <u>Transfer students who matriculate into Bradley prior to Fall 2018 will be offered</u> the choice of completing the General Education requirements as listed in the 2015-2016 <u>Undergraduate Catalog in lieu of the Bradley Core Curriculum, pending approval by their</u> program administration. Students must submit their request to meet the General Education requirements by May 1, 2018. This supersedes the following policy in the <u>Undergraduate Catalog under All-University Degree Requirements:</u> *"Students who maintain continuous enrollment and who complete work toward the baccalaureate degree within five years from the date of entry may graduate under either the catalog in effect at the time of entrance or under the catalog in effect at the time of graduation."* [Note, this policy will automatically expire June 1, 2018.

• Readmitted students will not receive transfer general education credit for the 300level writing requirement unless the course was taken at the 300-level. Readmitted students who attended Bradley University prior to the fall of 2015 may be required to satisfy the current Bradley Core Curriculum requirements. The college dean of the student's major makes the decision.

• Additional major or college-specific guidelines or policies may apply. Consult college and program requirements in the undergraduate catalog for more information.

• No more than two courses with the same subject prefix can be used to satisfy Area of Inquiry requirements in the Bradley Core Curriculum. This rule does not include the Communications Area of Inquiry.

## j. Bradley Core Curriculum Internal Policies

1. Course Syllabi. Instructors of general education courses are asked to help students understand how general education courses fit into their education as a whole. Students may not understand that many of the skills that employers value – effective communication, teamwork, flexible thinking, social understanding and more – are developed and refined in general education courses. In order to help student make these connections, faculty are asked to add the following to Bradley Core Curriculum course syllabi:

• A statement that the course is part of the Bradley Core Curriculum, and the category with which it is aligned;

• List the overall Core Outcomes and Area of Inquiry Curricular Elements that the course supports; and

• The link to the Bradley Core Curriculum program website.

Syllabi should be available no later than the first day of class.

2. Course Format. Faculty members are encouraged to use online tools and sustainable tools when making their syllabi available to students.

3. IAI Articulation. IAI and other transfer courses may be accepted for BCC credit without requiring an identified BU course equivalent. In the spirit of maintaining a transfer-friendly environment, IAI and other transfer courses that do not meet the course population rules for inclusion in a particular Area of Inquiry may be approved for credit on that Area of Inquiry if the Core Curriculum Committee deems it appropriate.

4. Transfer Articulation. The Core Curriculum Committee will periodically review transfer articulations and transfer policies to ensure the appropriate balance between transfer friendliness and integrity of the Bradley Core Curriculum. Case-by-case transfer course articulations will be determined by the Chair of the Core Curriculum Committee. Ongoing program review of the Core Curriculum will include data on transfer approvals and analysis of current transfer policies.

# A. Interim President Liberty

- 1. Weekly admissions reports will be posted starting tomorrow. Members of the faculty are encouraged to participate in recruitment
- 2. The Senate Executive Committee suggested placing an advertisement immediately announcing Bradley's search for a provost. The first meeting of the search committee for the new provost will be held next Thursday, December 17.
- 3. The "Giving Tuesday" campaign was successful.
- 4. Bradley's hard copy of this year's holiday card has been mailed.
- 5. Fall commencement will be held December 19 and there will be a few changes to the proceedings.

# **B.** Interim Provost Sattler

1. Graduate recruitment efforts for Spring 2016 are going well. We are working with four Chinese Universities for collaborative agreements: Yangzhou University,

Shanghai University of Science and Technology, Beijing University of Chemical Technology, and Donghua University. An international student website is currently being developed. A Pre-Orientation Informational Webinar for graduate students has been completed.

- 2. Twenty-two Sabbatical leave proposals have been approved for the 2016-2017 academic year.
- 3. The registrar has notified all students who had waitlisted classes that the waitlist has been cleared. Students are advised to go to Webster to check their schedules and contact their academic advisors if they have questions.
- 4. The study abroad class scheduled for London during the 2016 January interim will proceed as planned.
- 5. The USPC committee has met five times this semester. President Roberts will be informed of the progress upon his arrival. Accomplishments to date include:
  - a) revisions of Guidelines for the Academic Program Review Process,
  - b) acceptance of department reports that are due December 15, 2015,
  - c) brainstorming an "HLC Quality Initiative" for the campus,
  - d) discussions regarding needed internal and external environmental scanning by all units, and
  - e) a recommendation for use of an external consultant.
- 6. All faculty and staff are invited to attend the 2016 Spring Forum. Topics will include but are not limited to:
  - a) university-wide assessment on student learning,
  - b) UAchieve, the new program replacing the current degree audit program-DARS,
  - c) a demonstration of current on-line courses,
  - d) teaching with technology, and
  - e) Core Curriculum sessions.

## C. Vice President Anna

- 1. A projection of the 3-5 year outlook is dependent on enrollments, so it is a bit too early to make any projections without reliable data
- 2. Volatility in the financial markets is affecting the endowment. On October 30, the University endowment was \$280 million. The November 30 valuations will be available soon and are expected to be close to \$285 million. The peak valuation was slightly above \$290 million.
- 3. A modest operating deficit is expected for this year due to enrollments. The capacity of the endowment will be used to fund a very modest, bust sustainable merit salary and wage increase for the faculty and staff. They will apply for the 2016 calendar.
