MINUTES of the February 2020 meeting of the University Senate.

I. Call to Order at 3:10

II. Approval of the Minutes (See Attachement 1)

Motion: Stephen Banning No Discussion Approved.

III. Reports from Administrators

A. President Gary Roberts

- Presidential search is in its final phase. Decision within the next few weeks.
- A planned construction project to add a dining facility to be paid for by Aramark has been suspended because it can't get underbudget.
- Strategic Planning Committee has moved forward with deletions of programs proposed by the Provost: Physics and FCS. They have not opted to move ahead with proposed deletion of Theatre with a 7 to 6 vote. President Roberts is bringing this motion forward because he feels it's important for Senate to vote on them all. Without the Senate vote it looks like the University is caving in. It deserves an airing.
- Overview observations: If anyone thinks that Zakahi or Roberts enjoy this they are "delusional". Both were faculty and they consider those impacted to be respected colleagues and friends. Both believe that these recommendations are right for Bradley. Nobody WANTs to phase out programs nor are they questioning the value of the programs or the degrees they offer. Alumni have been well served by their education. It's a worthy program. This is not about the value of the programs – they are not making any academic or social judgements but instead are making business decisions. We are facing a \$10 million operating budget deficit that will be \$12 million in the next fiscal year so these cuts are about financial viability.
- Refers to the forums he held last November. At those forums where ideas were invited he suggests a turnaround agenda was developed that included controversial and risky initiatives, such as:
 - Increasing Online programs
 - Test optional
 - o Reducing labor costs and fees through benefit adjustments
 - Developing graduate and international students.
- One piece of this agenda is realigning resources and as a result of the 2 year Program Prioritization Plan (which he states was an open transparent and inclusive multi-year process) the Provost made these recommendations, and the Board was supportive of them in the February meeting (three mentioned who differed wanted deeper cuts including one Trustee who expected 10% cuts). The president asserts that when they were told there was pushback on this plan the Board was concerned. He states that the trustees will hear that the faculty is out of touch and are unwilling to participatE in seeking solutions. He states that we can "hack away" at the data but that's the path of doing nothing. We cannot maintain the status quo. Opposing because of imperfect data is not the path. These programs are chronically underperforming and are just 2% of the programs. It is almost certain that BOT will dismiss the faculty voice going forward. He fears that the concept of shared governance may be lost if the Board loses faith in the faculty judgment and courage.

Senate President Ahmad Fakheri:

- Comments about the process SPC used in forwarding program deletion items to Senate: a yes may just mean it should be forwarded and should not be taken as necessarily meaning support for deletion.
- Rules of procedure outlined. Limit Senators to 2 minutes each to speak. Non-Senators please limit comments to new facts or POV, don't repeat what's already been said. And Non-Senators need a motion to be allowed to speak and are asked to address prior to the senators' debate.

Senator J Bukowski: Re SPC vote. What is the basis for their vote? Is there vote just a decision to put forward for a vote these motions? Or is it a support for the cuts?

A. F. it could be that some are supportive but some just want it to forwarded.

J.B: Calls upon procedural questions. Handbook calls for "providing timely notice" and notes that it "shall be accompanied by comment from the unit being evaluated". This is in the Handbook, page 148, number 8. General procedures for SPC start on page 140.

A.F. This doesn't keep us from discussion.

Senator Kimberlin: PHY was not asked for this but they would be happy to do this. A.F: Is this sufficient notification?

K.K.: does not need a written notice but would like to write department's reaction.

Discussion included the following:

- Wording "Shall be" indicates that the written response is required, not something that can be opted out.
- Does this affect the Theatre recommendation?
- Inquiry about whether discussion could go forward at this time with vote in next meeting?
- Objection to discussion because these comments should be part of the current discussion.
- Vigorous support voiced.
- Proposal to discuss at meeting in March, provided 2 weeks is sufficient time for responses.

Senate President Fakheri clarified that the 4 units that are subject to this decision will submit their reaction in 2 weeks. They will be forwarded to Senators and will be subject of discussion at next meeting.

Senator G. Roberts: Common sense says treat theatre the same as the others.
